Subsequent to the Conference Michael Nilsson intended to relocate abroad and William Wolfe was appointed to replace him as PSO Delegate. Lee Hager had to step down as Publications chair due to his responsibilities as President Elect. He was replaced by Rena Glaser. Mike Dyer changed jobs and resigned as Chair of Public Relations to be replaced by John Elmore.

### **B.** Management Firm Activities

Transition from Executive Director, Inc. (EDI) to Great Western Association Management, Inc. (GWAMI) began immediately following the 1998 Conference. The transition was plagued with difficulties created by EDI failing to meet deadlines and deliver on promises. Among other surprises, GWAMI discovered that NHCA's incorporation had lapsed (EDI never reincorporated NHCA in Wisconsin), so GWAMI had to take care of this for Colorado. Much time was spent clearing up problems arising from the transition. And a major problem that was uncovered was in the commitments for the hotel for the Atlanta conference. Not only was the hotel under major renovation, and not only had the wrong rooms been booked, but it had been reserved for the wrong dates. So at the last minute, Julie Royster and the ED had to scramble to find a new site in Atlanta.

#### C. Summer Executive Council Meeting (July, 1998, Denver, CO)

- Evelyn Brust of GWAMI organized brainstorming sessions for an updated long-range plan. (Note: an interim report was issued, but has been tabled, and no final report was re-issued within the time covered by this archive report.)
- Jim Banach reported that he received very poor response from the council for his Ways and Means Committee efforts to think BIG on fund raising.
- The NHCA webmaster, Brad Whitlock of the Software Factory, provided a short presentation on the web page.
- A new schedule for mailing dues notices was approved, consisting of first notice (11/1/98), second notice (1/15/99), final notice (2/15/99), and cut off for the directory of 3/15/99, although changes were actually accepted up thru the end of May.
- Jim Jackson of project C.U.R.E. (Commission on Urgent Relief and Equipment) briefed the Council
  about the charitable actions of his organization that provides donated medical supplies and
  equipment to developing nations around the world.

### B. Membership and Directory

A directory was published in the summer of 1997, dated 1997-98, but none was published in 1998.

Total paid members through June 1999 were 479 (as compared to 459 in June 1998 and 652 in 1997). (All approved member applications after September 30 are placed in the 2000 membership year.)

## E. Excellence Seminar/Regional Meeting

The 9th Annual Excellence in Hearing Conservation Seminar was held on September 24, 1998 at the Radisson Hotel Seattle Airport, in Seattle, WA. There were six affiliates [3M, Dalloz, E•A•R, James Anderson & Associates, National Assoc. Of Special Equipment Distributors (NASED), Quest Technologies, and Software Resources & Marketing, Inc.], 37 paid attendees, and 7 presenters on the following topics:

Registration fees were \$140 for members, \$180 for non-members, \$50 for students (10 attended), and \$550 for affiliates. The meeting produced a profit of \$4,027. Unlike prior years, free Associate membership was no longer offered for non-members who attended the seminar.

#### F. Fall Executive Council Meeting (November, 1998, Denver, CO)

- Money was approved to file for incorporation in the state of Colorado.
- The bylaws ballot on whether to eliminate Associate members was defeated and the Council decided not to pursue the issue further at this time.
- The council decided that the archive report (this document) should continue to be prepared each
  year and that it should be included as one of the items in the new Council member orientation
  packet.
- Dorie Watkins reported on her incredible success with hearing education in the schools. Nearly 6,000 students participated in the Task Force's program in 1997/98. The Council approved \$600 to underwrite the cost of producing additional materials for the Task Force to distribute.
- Randy Tubbs updated the Council on the new NIH/NIOSH program to heighten public awareness about NIHL and about their concept to establish conferences on Best Practice. The Council decided it was vital to participate in this process.
- The Council approved the writing of a second letter, to be drafted by Elliott Berger, to the National Highway Traffic Safety Administration (NHTSA) about the auditory risks of airbags.

### G. Member Dues, and Affiliate and Exhibition Fees

Dues invoices for the 1999 membership year were mailed in November 1998. Dues amounts were as follows:

Affiliate fees for the 1999 Conference were \$1800 for commercial affiliates (2 free attendees, double exhibit space, 25% discount for 3<sup>rd</sup> and 4<sup>th</sup> registrants, 50% for additional registrants beyond 4) and \$1000 for non-profits (2 free attendees). Exhibition fees were:

### H. Annual Conference

The 24th Annual Hearing Conservation Conference was held February 25 - 27, 1999 at the Hyatt Regency

in Atlanta, GA. There were 192 paid registrants (158 prior year), and 250 total participants (227 prior year). There were 13 affiliates of which six were not for profit (designated by an asterisk) [AIHA\*, ASA\*, ASHA\*, CAOHC\*, Dalloz Safety, E•A•R, House Ear Institute\*, JAA, Moldex Metric, Peltor, Quest Technologies, WCB of British Columbia\*, and 3M], and a total of 25 organizations and companies were represented in the exhibit hall (27 prior year). Sponsors were solicited for various events and elements of the conference in addition to the normal solicitation for luncheon and break support. Five companies participated as sponsors with a total of \$1850 in support. The Silent Auction was hugely successful, with over 30 donations generating \$3076 of income. The meeting resulted in a profit of \$17,041, which was \$31,458 under budget. Failure to meet budget was due to higher than anticipated expenses for food, a/v, and a rental fee for the conference hall.

The faculty and program participants list in the Supplement consisted of 96 names; biographies were moved to the Proceedings to save cost. The five workshops were:

Effective techniques of successful hearing conservation programs

Marketing for those who want to challenge themselves to grow

Hearing protector stuff (taught in the AM only)

War of the worlds: Mock trial on hearing loss issues

Audiometric case management in hearing conservation programs

The Conference provided 3 Forums, 17 platform lectures, 3 practical pop-ups, 21 posters, a Film Theater with 3 films and 1 audio demonstration CD, and a luncheon lecture by motivational speaker Bruce Wilkinson.

The President's Reception was hosted on Wednesday evening following the Council Meeting, from 8:30 - 10:00 PM in the Presidential Suite. A total of a 55 members accepted the invitation with 3 declining.

Dorie Watkins coordinated the children's poster contest and the irrepressible Brian Myers (once again) won the NHCA luncheon Trivia Contest, which was organized by Mary McDaniel.

A lightly-attend Friday evening Gala event, with pleasant jazz, was held in one of the hotel ballrooms.

## I. Annual Business Meeting

Due to last-minute changes in the program to include a NIH/NIOSH presentation by Max Lum and Marin Allen on the NIH/NIOSH public awareness campaign, an exceptionally brief business meeting was conducted.

### J. Executive Council Meetings at Annual Conference

- Julie Royster resigned as Vice President. Mark Stephenson was appointed as her replacement.
- GWAMI agreed to extend their contract with NHCA thru June 30, to be consistent with NHCA's fiscal year.
- The Council agreed that the use of funds for timely broadcast faxes should be encouraged and continued.

#### K. Publications

NHCA published four regular issues of the Spectrum and one supplement (a Conference program) during this time period under editors Lee Hager and Rena Glaser.

## L. Position Statements/Regulatory Involvement

NHCA participated in the NIDCD/NIH/NIOSH strategic planning for a heightened public awareness campaign and published a position statement in the April, 1999 *Spectrum*.

### M. Changes to Bylaws

A bylaws ballot was mailed on September 3, with a close of voting of October 9, 1998. Seven items were up for vote, six of which passed (clarification of who can be an officer, officer can run for two consecutive terms, adding a second Member delegate, clarification of the voting procedures for the Executive Council, description of an impeachment process, and addition of a Committee on Scholarship). The seventh and most serious of the items, the elimination of the Associate Member category failed by a vote of 67 yes and 51 no (a two-thirds majority of 79 votes was required). This topic had been discussed at length and the Council decided that it did not require any further examination in the near future.

### O. Year-End Financial Statement

The financial statements (see attached) for the 7/1/98 - 6/30/99 fiscal year reflect a net income over expense of \$4,993.71 under the accrual method of accounting, which GWAMI prefers for not-for-profit organizations, over the net profit method of accounting.
